#### 1.3 Mission



  - Certified true copy of TOEFL/IELTS (non-Malaysian)
  - Certified true copy of SPM result slip (Malaysian)
  - Five (5) photos (non-Malaysian) and four (4) photos (Malaysian) of passport-sized photos (blue background)
  - Four (4) copies of every page of International Passport (non-Malaysian)
  - Letter of undertaking for scholarship/training award/study loan (if applicable).

#### 6. DURATION OF STUDY

#### **Full-time**

Postgraduate Diploma programme – Minimum and maximum 3 semesters Master programme - Minimum 3 semesters and maximum 10 semesters PhD programme – Minimum 4 semesters and maximum 12 semesters

#### **Part-time**

Postgraduate Diploma programme – Minimum and maximum 5 semesters Master programme - Minimum 4 semesters and maximum 14 semesters PhD programme – Minimum 8 semesters and maximum 16 semesters

#### 7. ENTRY QUALIFICATION

#### 7.1 Academic Requirement

#### a. Doctor of Philosophy Programme (PhD)

- Master's Degree holder in relevant field from Sultan Abdul Halim Mu'adzam Shah International Islamic University or any institution of higher learning recognized by the University Senate; or
- Any other equivalent qualification recognised by the University Senate.

#### b. Master's Programme by Research Mode and Mixed Mode

- A Bachelor's Degree in related fields with a CGPA of at least 2.75 from UniSHAMS or from a university recognized by the government and approved by University Senate; or
- A Bachelor's Degree or equivalent with minimum CGPA of 2.50 (and not meeting the normal CGPA of 2.75), may be accepted subject to rigorous internal assessment; or
- A Bachelor's Degree or equivalent not meeting CGPA 2.50, may be accepted subject to a minimum of FIVE (5) years working experience in relevant fields.
- Any other equivalent qualification recognized by the University Senate.

#### c. Master's Programme by Coursework

- A Bachelor's Degree in related fields with a CGPA of at least 2.5 from uniSHAMS or a university recognized by the government and approved by University Senate; or
- A Bachelor's Degree or equivalent not meeting CGPA of 2.50 with a minimum of 5 years working experience in relevant fields, may be accepted.

• Any other equivalent qualification recognized by the University Senate.

#### d. Postgraduate Diploma

- Bachelor's degree in Law or Syariah or equivalent; or
- Any Bachelor's degree or equivalent with at least 3 years of working experience in related fields.

Applicants who do not meet the minimum requirements for the programme they have applied, may be offered admission to another programme requiring lower qualifications.

#### 7.2 English Requirement

- a. Students are required to demonstrate their proficiency in English. Applicants must produce evidence of their language proficiency which must be attached to the application form.
- b. All foreign students must attach TOEFL/IELTS certificates. They must meet the minimum score of 600 for TOEFL or 6.0 for IELTS.
- c. Students who fail to meet the TOEFL / IELTS requirements, have to register in the preparatory class offered by the University and must obtain the minimum score as stipulated in (b) clause within 6 months from the date of admission.


